The Japanese-Language Proficiency Test (JLPT) December 2026 Instructions for Requesting Special Testing Accommodations -Overseas Edition-

Special Testing Accommodations (STA) may be provided for examinees with disabilities. Those who wish to apply for special testing accommodations should apply after reading this document in full.

1. Documents to be submitted

Include all documents together. If documents are supplied piecemeal over several emails, it risks material being omitted or confusion over which version of a document is correct.

(1) STA Request Form (受験上の配慮申請書)

(2) **Completed JLPT Application Form** – this might be visible in the Order Confirmation receipt email. Otherwise, it is viewable in Eventbrite. Steps will differ depending on device (app / phone / computer) but as a rough outline: login or create an Eventbrite account matching the email address that was supplied during registration and payment. Go to “Tickets”, then “(See) past orders”, then expand the details to view application form answers. Seen from a desktop browser, that final expanding link is labelled “View complete attendee info”.

(3) Attachment to STA Request Form (Medical Certificate, audiogram etc.)

Documents listed at 3.(2) in 2nd page of the STA Request Form. (Medical certificate etc.) (“Attachment”). If the exact same STA has been requested and provided in a past JLPT, outside Japan, within the last 3 years (meaning on or after JLPT December 2023), it is not necessary to submit medical certificates etc. again. Otherwise, evidence supplied to support an STA application must be within 12 months of issue and the medical professional must be contactable for verification. Supporting documents may vary depending on the type of STA request. Please refer to page 2-7 of the STA Request Form for detail. Please refer to page 4-5 in this document for extended test time.

2. STA Application process

(1) Register for the JLPT using either (A.) or (B.) as appropriate.

NOTE: Just answering the STA question(s) on the JLPT registration form alone DO NOT mean you have applied for STA. It only indicates your intention to apply for STA.

A. JLPT with STA (no separate room)

Apply and pay for the JLPT by using one of the main JLPT registration links on the JLPT webpage for Australia (<https://sydney.jpj.go.jp/language/for-learners/jlpt/>). On the JLPT application form, select the appropriate answer for the question that mentions non-separate room STA.

B. JLPT with STA separate room (and/or time extension)

DO NOT use the main JLPT registration links. Instead use a different set of links, past example shown in the image. They are located on the JLPT webpage for Australia.

Applications open on Aug 28, at the same time as regular JLPT applications. First come, first served basis.

- (2) **STA Request Form (受験上の配慮申請書)** – after registering and paying for the JLPT on Eventbrite, all STA requests (separate room or not) need to complete the STA Request Form that is found in the STA ZIP.
- (3) Submit all articles in step “1. Documents to be submitted” by email to The Japan Foundation, Sydney (jlpt_sy@jpf.go.jp). It is also permissible for a representative to apply on your behalf.
- (4) **STA Application period:** Aug 28 (Fri) – Sep 10 (Thu)

The deadline applies to all STA procedures including registering via Eventbrite and submission of the STA Request Form and supporting evidence. Strictly no late submissions will be accepted.

In the case of separate room STA, late or non-submission of the STA Request Form will result in the JLPT application being cancelled without refund. Application for separate room STA also disqualifies the possibility of attempting the test in a regular test room with non-STA examinees, even if the STA application was made in error or carelessness.

3. Decision process regarding the implementation of STA:

- (1) The Japan Foundation, which organizes the test, in consultation with the Committee for Special Testing Accommodations, will decide what STA should be put in place based on the contents of request form and attached documents. However, please note that some requested accommodations may not be granted.

WARNING: Be extremely careful about arranging advance travel and accommodation if you are unable to undertake the JLPT without your STA requests.

- (2) If the information provided on the request form is not sufficient, the Japan Foundation may contact applicants or their representative to request further information.
- (3) In the case of non-separate room STA, if an applicant fails to complete the STA application procedure by the deadline, or if the STA request is unsuccessful, the applicant has the option of attempting the Test under the same conditions as non-STA examinees.

(4) Applicants or their representative will be notified of the final decision regarding the special testing accommodations around the beginning of November.

(5) All communication between applicants or their representative and the Japan Foundation will be conducted through the host institution.

(6) STA examinees must respond to communications; including those from the Host Institution. Communication timelines will vary between specific hosts. Failure to reconfirm as requested may result in the unavailability of separate room, extra time and/or other requests that had been granted.

(7) If a STA examinee becomes unable to attend the test, they must inform the host institution as soon as possible or by noon, one day before the test (Saturday) at the latest.

4. Notification of results

The notification of test results will not make any mention of the special testing accommodations, except for Listening Test exemption, unless applicant requests to the contrary.
